



Privacy Statement

We respect the privacy of our website visitors and ensure that the personal information you provide is treated confidentially. Processing of the personal data takes place in accordance with the requirements of the General Data Protection Regulation.

PERSONAL DATA PROCESSED

1.1 JOA Ventures BV and/or affiliated Companies (further named JOA) can process personal data from you when you use services of JOA, and/or because you completed a Contact Form or Newsletter Subscription Form on the JOA website. JOA can process the following personal data:

- Your name and surname
- Your title
- Your address details
- Your phone number, both fixed and mobile

WHY JOA NEEDS DATA

1.2 JOA processes your personal data to be able to reach you by telephone, by email, or in writing regarding current and/or future projects and/or services and/or investments. In addition, JOA can use your personal data in the context of executing contracts or services agreements, usually consisting of the development, innovation, realization of technical developments or investments in the field of Energy, Software, and/or Biotechnology.

HOW LONG JOA SAVES DATA

1.3 JOA saves personal data no longer than strictly necessary to achieve the objectives for which your data is collected. Once every five years, the database will be checked by email asking your permission to keep your data longer.

SHARING WITH OTHERS

1.4 JOA only provides your personal information to third parties if it is necessary for the execution of an agreement with you, or to comply with local regulations.

MAPPING WEBSITE VISITS

1.5 On the website of JOA general visitor data is kept, including the IP address of your computer and the time of retrieval and data that your browser sends. This data is used for analysis of visitor data and click behavior on the website. JOA uses this information to improve the operation of the website and its Analytics online services. The data is anonymised as much as possible and it is not provided to third parties.

NEWSLETTER

1.6 We may offer newsletters with which we want to inform interested parties about news in the field of Software, Energy, or Biotechnology, or of our services and related matters. Your e-mail address will only be added to the list of subscribers with your explicit permission. Each newsletter contains a link with which you can unsubscribe. The subscriber file of the newsletter is not provided to third parties.

SOCIAL MEDIA

1.7 The website and our newsletter contains buttons for promoting or sharing pages on social networks such as Facebook, Twitter, and LinkedIn. These buttons are implemented by a code provided by Facebook, Twitter, and LinkedIn itself. This code places, among other things, a cookie. Read the privacy statement of Facebook, Twitter, and LinkedIn (which can change regularly) to see what they do with your personal data that they process with this code. This also applies to other social media channels.

GOOGLE ANALYTICS

1.8 JOA uses Google Analytics to track how users use the website. The information thus obtained, including the address of your computer (IP address), is transferred to and stored by Google on servers in the United States. Google uses this information to track how our website is used, to reports on the use of the website to JOA and to be able to provide its advertisers to be able to provide information about the effectiveness of their campaigns. Google may provide this information to third parties if Google is legally obliged to do so, or insofar as these third parties process the information on Google's behalf. JOA has no influence on this.
